3. The bid price in **Kenya shillings** should include **16% Value Added Tax** (16% VAT) and this should be specified clearly in the “Returnable Bidding document.”
4. Sealed bids to be addressed to the undersigned and dropped in the tender box provided.
5. The tender box is placed at **the Administration office, Siginson Global Logistics offices located off Lumumba Road in Mombasa**. Bidders should provide their full contact details including email addresses and current telephone numbers.
6. Bidders are required to complete a bid register that will be available at the reception with details of their names, date, and time of their bid submission when submitting their bids, Failure to comply with this requirement shall render a particular bidder's bid void, therefore the said bid shall not be considered by Siginson Group.
7. The declared winning bidder shall be required to make payment through the **Siginson Group Ltd bank account** to be provided after the sale within 5 days after official communication from the **Tender secretary** failure to which the asset shall be sold to the second-highest bidder.
8. The declared winning bidder for the vehicle will be required to show proof of payment before Siginson Group surrenders the logbook.
